

Access to buprenorphine to treat opioid use disorder remains stable.

Medications to treat opioid use disorder (MOUD) have marginally increased in the past five years from 14.54 million to 16.05 million. The AMA urges removal of all barriers to MOUD and greater enforcement of parity laws to ensure equitable, affordable access to MOUD.
