\*For the purposes of CPT coding, "Immunization" includes vaccines/toxoids, immune globulins, serum or recombinant products.

For this reason, code numbers and/or descriptor language in the CPT code set may differ at the time of publication. In addition, further Panel actions may result in gaps in code number sequencing.
